So why are we recommending a merger?


It's the long-term concerns!





Why have we recommended merging to form a regional land trust?

- Connectivity across towns & visibility across region = new partnerships.
- Protect more land & greater ability to steward properties = greater local impact on climate change.
- Increase members, volunteers, and donors = more funds, capacity, & potentially paid staff.
- Combined operating revenues, unrestricted funds, and restricted funds. Plus Peter & Carmen Lucia Buck Foundation offered \$50,000 per year.
- <u>Ultimately stronger financial health and longevity to</u> <u>ensure the perpetuity of our entrusted lands.</u>



Merger Lexicon

March 8, 2023, WLT BOD approved a resolution recommending the Plan of Merger and pre-authorizing steps to implement the Plan:

- Plan of Merger with
 - New by-laws
 - Amended Certificate of Incorporation
 - New Board of Directors
 - New name: Traprock Ridge Land Conservancy
- Definitive Merger Agreement (legal agreement between the three land trusts to implement the Plan of Merger pending member approval)

Plan of Merger Summary

- EGLT and WHLT transfer assets to WLT (WLT is the surviving entity).
- Create a new entity with a new name (but with the same tax ID #).
- Current members of WLT (lifetime & annual) automatically members of new entity.
- Properties transfer to new entity with donor restrictions identified & protected (due diligence has been performed on all properties identifying restrictions & covenants).
- Financials combined with donor restrictions identified & preserved.
- Programs continue once the entities merge, e.g.
 - Farms & associated leases,
 - Use selected lands for passive recreation & education, e.g. LaSalette Trail in Bloomfield and connecting Howard Preserve to Seymour School in East Granby,
 - Film recycling program in West Hartford, and
 - Internship program in East Granby (and hopefully expand).

Proposed Resolutions of the Members of Wintonbury Land Trust, Inc. for 3/29/2023

WHEREAS, Wintonbury Land Trust, Inc. ("Wintonbury"), West Hartford Land Trust, Inc., ("West Hartford"), and The East Granby Land Trust, Inc. ("East Granby") have engaged in negotiations regarding the merger of East Granby and West Hartford with and into Wintonbury in accordance with Section 33-1155 of the General Statutes of the State of Connecticut (the Act");

WHEREAS, the Plan of Merger, including the Amended and Restated Bylaws and Amended and Restated Certificate of Incorporation of Wintonbury, were provided to Wintonbury's members (the "Members") with the Notice of the 3/29/2023 Special Meeting of the Members; and

WHEREAS, a Special Meeting of Members was held 3/29/2023 at which a quorum was present and at which the Board of Directors' recommendation of the adoption of the Plan of Merger by the Members of Wintonbury was heard, and the following resolutions were adopted:

RESOLVED: That the Members hereby approve and adopt the Plan of Merger in the form set forth as **Exhibit A**.

RESOLVED: That the Members agree that West Hartford and East Granby merge with and into Wintonbury on such terms and conditions deemed reasonable by Wintonbury's Board of Directors, acting through its President.
